## DEED OF GRANT OF LAND

Land Act 1962 - 1989

Elizabeth the Second, by the Grace of God, Queen of Australia, and Her other Realms and Territories, Head of the Commonwealth:-

## TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

We, with the advice of the Executive Council of Our State of Queensland, and in pursuance of the provisions of the Land Act 1962 - 1989, do hereby Grant in fee simple unto the person described in the Second Schedule hereto, ALL that Parcel of Land in Our said State described in the First Schedule hereto and delineated on plan registered in the Department of Geographic Information and having Catalogue Number as stated in such First Schedule, SUBJECT TO the Reservations and Conditions hereinafter specified, and such other Reservations and Conditions as may be contained in and declared by the Laws of Our said State.

## Specified Reservations -

- 1. (a) All minerals (as defined by the Mining Act 1968 1986) on and below the surface of the land; and
  - (b) The right of access for the purpose of searching for and working any mines (as defined by the Mining Act 1968 1986) in any part of the land
- 2. (a) All petroleum (as defined by the Petroleum Act 1923 1986) on or below the surface of the land; and
  - (b) All rights of access for the purpose of searching for and for the operations of obtaining petroleum in any part of the land, and all rights of way for access and for pipe-lines and other purposes requisite for obtaining and conveying petroleum in the event of petroleum being obtained in any part of the said land.
